1. The meeting was called to order at 6:18 p.m.

2. Announcements and Comments:

- The Quarter Midget Racing Club obtained an extension on their lease of the raceway.
- The Ready by 21 Coalition will send representatives to the December meeting.

3. Approve Minutes of October 15, 2007 Meeting

Katie motioned to approve the October 15, 2007 minutes and Raylia seconded. The minutes were approved as written.

4. Monitoring of Board of Supervisors Agendas

- > October/November report made by the District 2 Commissioners:
 - Was a modified contract in the Youth Detention Facility Expansion and Modification Project
 - Increased security in malls for the holiday season
- November/December agenda monitoring is assigned to District 3 Commissioners

5. Discussion of Response to the Crocker Art Museum Proposal

- A representative from the Crocker Art Museum, Caren Gutierrez, attended the meeting to discuss the project
- Suggested to combine it with the Big Name, Small Art Auction held at Cal Expo that the Crocker holds annually. However, this is not ideal because the money raised is used by the museum for acquiring art rather than for expanding the museum and there is alcohol present at the event.
- Concerned that there will not be enough room available in the museum itself to exhibit the artwork. The expansion will bring larger exhibitions to the Crocker. In the past, there was a special room designated for student exhibitions but there is no more access to this room.
- In order to raise awareness and involvement of the youth about the expansion project, there were suggestions to have the schools host to the auction and collectively donate to the capital campaign.
- Eventually, it was decided that the auction/one-day exhibit would take place in Crocker Park during the summer. This would solve the problem of space and allow the artists the opportunity to display their artwork. If desired, the artist could auction off their artwork to contribute to the funds for the Crocker's expansion project. Because the event will be an auction rather than an exhibit, no entry fee will be required. Schools will be given an opportunity to donate money to the Crocker. The current plan is to have a whole day auction and offer an incentive to the art department of the school that raises the most money or has the most applicants.

6. Coats for Kids Drive

- The confirmed locations are Mira Loma, Inderkum, and Franklin High Schools, as well as in the County buildings downtown and at Mather.
- Sylvia will distribute the bins, on loan from County Waste Management, and signs to place at these locations.
- The drive will end by winter break and the commissioners will gather to collect the coats and bring them to News 10.
- Sylvia distributed her contact information to the commissioners so that they could pass it on to the administrators of the prospective locations where the bins would be placed.
