1. The meeting was called to order at 6:19 p.m.

2. Announcements and Comments:

- ➤ The Sacramento Youth Commission introduced themselves to the new commissioner, Christopher Eur, a sophomore at Jesuit High School, who will be filling in the vacancy in District 3.
- ➤ Paul Hicks, Senior Program Associate for the Sacramento County Children's Coalition, wanted to invite commission members to aid in the presentation of the Children's Report Card. The Report Card is created every two years and covers a wide range of children

and youth issues. The Children's Coalition is an advisory board that presents to the Board of Supervisors, and they need youth co-presenters. There are two presentation dates, which occur during school hours, on November 18 and November 21. There are ongoing presentations throughout the school year and it can count for community service volunteer hours.

3. Approve Minutes of September 15, 2008 Meeting

- > Trade Schools Brochure

- > Transportation Project
 - Megan was not present to discuss the project. However, there were suggestions to just include a link on the commission website to the Regional Transit website.
- Crocker Art Museum
 - Our former contact, Caren, is no longer working at the museum. The museum has announced the formation of its own youth advisory board, so this project will probably be put on hold until we can contact this board.
- Youth Issues Survey
 - Betsy Braziel suggested that we integrate the survey on our website and work on marketing the survey to more youth. We could separate the survey into more manageable sections and place them on our website quarterly, addressing each issue individually.

 The commission should also contact the Boys and Girls Club for distributing the survey and look into the Youth Development Network.

7. Other Business

Michele will not be here for the next meeting, so Alan Lange will be the advisor for the November meeting.

8. Public Comment on Non-Agenda Items

- ➤ Several concerned family members made assertions of staff misconduct and abuse of wards at Sacramento County juvenile detention facilities. These parents shared stories of mistreatment of their children, as well as processes/policies that limit the amount of information and access parents receive when their children are injured.
- > The parents want the county to take action on the issues they've raised.
