- 1) Welcome & Introductions:
 - a. Commissioners introduced themselves and welcomed new Commissioner India Eason.

- 2) Approve Minutes:
 - a. On a motion by Commissioner Eleanor Love, seconded by Commissioner Hailee Makin, the November 2, 2020 meeting minutes, as revised, were unanimously approved by those members present.

- 3) Sacramento County District Events
 - a. District 1: Commissioner Eleanor Love presents the Much

Ado About Nothing play hosted virtually by C.K. McClatchy, all through the week of December 14, 2020 to December 18, 2020.

- b. District 4: Commissioner Aarthi Sridhar presents the Virtual Walk Through Holiday Lights hosted virtually by Lincoln Park Zoo on December 19, 2020 from 5pm to 5:45 pm.
- 4) Review Of Board Of Supervisors Agendas And News Articles:
